

**SANDOVAL COUNTY BOARD OF COMMISSIONERS
REGULAR MEETING MINUTES
COMMISSION CHAMBERS
SEPTEMBER 5, 2013 – 6 P.M.**

1. CALL TO ORDER

The meeting was called to order at 6:02pm.

Present were Chair Madalena, Vice Chair Scherzinger, Commissioner Lucero, and Commissioner Chapman. Commissioner Walters arrived at 6:07p.m.

Commissioner Chapman stated many residents in his district are pleased with road improvements in their neighborhoods. Vice Chair Scherzinger thanked Manager Rios for his monthly report. Commissioner Lucero asked about progress on the Torreon Road Project. Manager Rios and Director Mora stated that they are ahead of schedule. Commissioner Walters requested a letter of thanks to Paul Gutierrez, since he is leaving the Association of Counties. Manager Rios stated the County received a letter concerning the property tax rate. He advised the Commissioners they are required to meet within five days to review, approve and order the Assessor to impose the rates. Commissioner Walters suggested attending the meeting telephonically, since several Commissioners will be unavailable. Attorney Trujillo advised that would be acceptable according to the resolution. Treasurer Montoya strongly suggested meeting within the five day requirement. Chair Madalena is sending a letter to the Commissioners concerning an elementary school in Jemez Pueblo not being allowed to participate in cross country.
