ACTION REQUESTED:

Adopt Resolution No. 4-3-14.10 Authorizing Sandoval County's 2014-2015 County Road Improvement Projects with the Local Government Road Fund Cooperative Agreement Program Administered by the New Mexico Department of Transportation for \$2,411,682.57

WHY ACTION IS NECESSARY (Summary):

The Public Works Department is required to submit road projects every year in order to be eligible to participate in the States Cooperative Program. We are submitting projects that total more than what we have received in the past. Once the agreements and awards are executed, the projects will be finalized from the list submitted under this resolution. This year Sandoval County received \$487,235.00 in Cooperative funding with the required local match of \$162,472 for a total of \$649,707. We are recommending that the following projects be approved as roads needing improvements by this resolution: Northern Blvd., County Rd 11, Old Mission Road in Torreon, and Edith Rd. in Bernalillo.

2014/2015 ROAD CO-OP
