

**SANDOVAL COUNTY BOARD OF COMMISSIONERS
REGULAR MEETING MINUTES
COMMISSION CHAMBERS
OCTOBER 16, 2014 – 6 P.M.**

1. **CALL TO ORDER**
Chairman Madalena called the meeting to order at 6:13 p.m. Present were Chairman Madalena, Commissioner Scherzinger, Commissioner Chapman and Commissioner Walters. Vice Chairman Lucero was absent.
